I am a primary producer as defined in the *Animal Management (Cats and Dogs) Act 2008*.

Primary producer – a) Means a person primarily engaged in the occupation of a-

- i. Dairy farmer; or
 - ii. Wheat, maize, or cereal grower; or
 - iii. Cane grower; or
 - iv. Fruit grower; or
 - v. Grazier; or
 - vi. Farmer, whether engaged in general or mixed farming, cotton, potato, or vegetable growing, or poultry or pig raising and
- b) Includes a person engaged in primary production

Working dog a) Means a dog usually kept or proposed to be kept-

- i. On rural land; and
- ii. By an owner who is a primary producer, or a person engaged or employed by a primary producer; and
- iii. Primarily for the purpose of-
 - A. Droving, protecting, tending, or working stock; or
 - B. Being trained in droving, protecting, tending or working stock; and

b) Does not include a class of dog prescribed under a regulation.

I declare that the information provided by me in this application is complete, true and correct in every detail. I understand that it is an offence under section 204 of the *Animal Management (Cats and Dogs) Act 2008* to provide false or misleading information that I know is false and misleading.
