

# **Excess Animal Application Dog Application Number**

Subordinate Local Law No. 2 (Animal Management) 2011
Subordinate Local Law No. 1.5 (Keeping of Animals) 2011

### Approval is required to keep more than:

- two dogs over three months of age on an allotment less than 2500m2 (maximum 4 dogs)
- three dogs over three months of age on an allotment between 2500m2 and 4000m2 (maximum 4 dogs)
- four dogs over three months of age on an allotment between 4001m2 and 40000m2
- five dogs over three months of age on allotments greater than 40000m2 OR
- one dog over three months of age on a multi-residential premises (i.e. unit) (maximum 2 dogs)

### Applications will only be approved in extraordinary circumstances.

**Example of extraordinary reasons** – Extraordinary reasons are such that unforeseen circumstances make the caring for a dog impossible, such as;

- Death or serious illness of a family member
- Member of a family moving into a retirement or care facility that does not allow dogs
- Unforeseen circumstances necessitating a move onto a smaller block or into the designated town area

Each application will be considered on its merits. Applicants must display responsible animal ownership and have no history of non-compliance with State or Council requirements pertaining to Animal Management.

An action plan to reduce the number of dogs on the property must be supplied as part of this application.

Please allow 6-8 weeks for your application to be processed, you will be notified in writing of the outcome. If further information or follow up is required, this may delay the decision process.

NB: An application fee is due on submission of this application. If your application is unsuccessful the application fee <u>WILL NOT</u> be reimbursed. Dog registration fees will apply to the excess dog(s) and are to be paid in full on application.

## 3. Information for Responsible Pet Ownership

### By lodging this application you understand:

- The application fee required on submission is non refundable.
- Payment of your dog registration fees and lodgement of registration forms will be required at the time you submit this excess animal application.
- If your dog(s) are not approved, your registration may be refunded prorata once your dog is no longer living at your home (e.g. rehomed, surrendered or deceased) evidence will be required.
- Council officers will be required to inspect your premises as part of processing your application before it is considered by Council.
- To ensure that the approval holder meets the conditions of an approval, Council may, at any time, revoke an approval if there is non-compliance with the conditions.

### Conditions include:

- > All dogs must be microchipped and registered at time of application lodgement.
- Not keeping more than the number of dogs than specified in this application.
- > The approval is granted for the dogs specified and is non transferrable to a new dog.
- > Approval is only given for the term of one calendar year. At the end of this term an application may be made for a renewal permit. The cost of issue of a renewal excess permit is \$50. Council will contact the animal owner to confirm if a renewal is required. Please note that this fee is additional to dog registration renewal which is required to be paid by June 30 each financial year.
