1 INTRODUCTION AND SCOPE

- 1.1 Council offers for sale vacant land located at 22 Tyrconnel Street, Mungallala Qld 4467.
- **1.2** Tyrconnel Street is the Warrego Highway through Mungallala.
- **1.3** This Part 3, the Specification, defines the property offered for sale.

2 BACKGROUND INFORMATION

- **2.1** The property is located at 22 Tryconnel Street, Mungallala on land described as Lot 2 on M5449.
- **2.2** This property is zoned 'Township'.
- **2.3** Lot 2 on M5449 has a land area of approximately 2,023 square metres.
- **2.4** Mungallala is a small community on the Warrego Highway located 45km west of Mitchell.
- 2.5 In addition to a hotel that offers accommodation and camping, the town of Mungallala has a post office, library, school, police station and recreation grounds.
- 2.6 Lot 2 on M5449 is on the Queensland Environmental Management Register due to its past use as a fuel station. The fuel bowser and underground fuel tank is still on site. No decontamination or rehabilitation works have taken place on site.

3.1 Property Offered

The property is zoned 'Township' under the Maranoa Planning Scheme.
